## Chromebook Damage Protection Program 2017-2018 School Year

**Please read this entire document to determine if this program is desired for you and your student to provide protection against damage and/or loss of the Chromebook in your care.**

**COVERAGE AND BENEFIT:** This program covers the Chromebook loaned to the student against accidental damage (Damage). Total cost of the Damage (actual cost of parts plus labor for Damage) will be determined by Suffield Public Schools.

**Please see reverse side for what this Program specifically covers and Common Charges:** Damage that occurs from lack of appropriate care of Chromebook may not be deemed as accidental. This program does not cover intentional damage by the covered student or household members. Assessment of any damage is to be determined by Suffield Public Schools.

**EFFECTIVE AND EXPIRATION DATES:** This coverage is effective from August 1, 2017 through July 31, 2018

**PREMIUM:** The total premium cost is \$30. In the event of student withdrawal from the District, the premium is not refundable. The District reserves the right to cancel the program if carelessness or abuse is determined. **PAYMENT IS DUE BY August 31, 2017. Please mail to 350 Mountain Road, Attn: Jamie Neilson or drop off at Central Office.**

**PROGRAM DESCRIPTION:** The District offers your student the opportunity to participate in this Computer Damage/Loss Cooperative Program. This program is designed to protect students and families in the event the Chromebook is lost, stolen, or damaged as described above. A separate form must be completed for each Chromebook covered; one form per student is required. **If you do not elect this program, the Chromebook replacement and damage costs are fully paid by the family.**
